

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:

On the above date and time, the defendant, Mr. Harry Ransom Joiner III, did commit the following crimes of Criminal Mischief F.S.S. 906.13, two counts Misdemeanor, and Disorderly Conduct F.S.S. 877.03 - Misdemeanor.

The defendant entered the Exxon Mobil Gas Station located at 3210 South Fiske Boulevard and asked the owner/victim Mr. Patel, to use the designated male restroom. The victim stated to the defendant the restrooms were only accessible to paying customers. The defendant proceeded to walk towards the restroom door and turned away from the restroom door and faced the corner. The defendant is observed standing in the corner facing a pallet of cased bottled water. This victim observed the defendant urinate on the bottom half of the cases of water. This outraged the sense of public decency and affected the peace and quiet of the victim. The defendant thereby committed Disorderly Conduct F.S.S. 877.03. The defendant willfully and maliciously damaged four cases of bottled water by urinating on this property being owned by the victim. The total loss value for the four cases of water is \$26.00.

As the defendant exited the store the defendant willfully and maliciously damaged one pair of sunglasses by grabbing the display and knocking multiple pairs onto the floor. The one pair of Foster Grant sunglasses loss value is \$11.99. The defendant thereby committed Criminal Mischief F.S.S. 806.13.

The above crimes are supported by urine located on the floor and cased water, the victims sworn statement and video surveillance footage capturing the entirety of the incident.

Pursuant to Florida State Statue 938.27, investigative costs incurred in this case are \$259.84.
