I observed the driver and the front seat passenger not wearing a seatbelts. I could clearly see that both the driver of the vehicle and the front seat passenger did not have on their seatbelts because the straps to the seatbelts were not across their chests. Both the driver and the front seat passenger had on white shirts making it easy to determine if the seatbelts were in use. Officer Tulier proceeded to conduct a traffic stop. I approached the front seat passenger of the vehicle by walking up to the passenger side of the vehicle. As I conducted a plan view search of the vehicle and the front seat passenger, I immediately observed a large bulge in the front seat passenger's right pocket of his pants. I asked the front seat passenger who was identified as Brandon Bernell Brown what was in his pocket. B. Brown did not reply and proceeded to look away from me. Through my training and experience, I recognized the configuration and the shape of the object in his pocket to be a handgun. I asked B. Brown what was in his pocket and told him to look at me. B. Brown began to place his hand in his right pants pocket. I ordered B. Brown not to place his hand in his pocket and asked again what was in his pocket. B. Brown did not answer me and continued to place his hand in the right pocket of his pants. I pulled out my firearm and pointed it at B. Brown's person and ordered him to take his hand out of his pocket. As B. Brown pulled his hand out of his pocket, I observed the handle of a black in color handgun sticking out of B. Brown's right pants pocket of his pants. I ordered B. Brown to place his hands on his head. B. Brown complied and placed his hands on his head. I was able to escort B. Brown out of the vehicle. Once B. Brown was out of the vehicle, I was able to secure the handgun from his right pocket of this pants. I was also able to secure from the front right pocket a brown cut cigar tube. I was able to observe a white chalky substance inside of the tube. Through my training and experience, I recognized the white chalky substance to be crack cocaine. I was also able to secure a clear plastic bag containing a green leafy substance from the left front pocket of B. Brown's pants.

After securing the handgun it was determined that the handgun was an (Airmag C11) airsoft BB gun. I was also able to secure two filled gas capsules that were in his left pants pocket. I placed the airsoft handgun and the capsules into evidence. With my department issued field test kit, I was able to field test the white chalky substance with positive results indicating marijuana. I was also able to field test the green leafy substance with positive results indicating marijuana.

I was able to transport B. Brown to the Cocoa Police Department for booking. B. Brown was later turned over to the B.C.S.O. jail. B. Brown received citation (AM9PJP) for no seatbelt.
