The defendant is Spanish speaking, but he stated that he had been drinking at his friend's apartment. The defendant stated that he had at least three beers.													
zippe	I asked the defendant to exit the vehicle. As the defendant stepped out of the vehicle, I again observed that the zipper of his shorts was open. The defendant was asked if he would be willing to perform field sobriety exercises to which he agreed. A Spanish speaking officer assisted with the Field Sobriety Exercises.												

The defendant stated he did not. The defendant was read the instructions for each exercise and the exercises were demonstrated for the defendant in Spanish. The defendant stated he understood the instructions.

The defendant was asked if he had any medical issues that would prevent him from completing the exercises.
