On December 29, 2024, I responded to a call of a Suspicious Incident at Tamango Drive and Eber Blvd. Upon my arrival, observed a grey 4 door Mitsubishi bearing Florida tag #RSCD32 parked at the exit gate on Tamango Drive. The vehicle was on the wrong side of the road. I was then informed by a male witness that he observed the driver of the vehicle slumped over the wheel. The witness then called 911.

I made contact with the driver, Alexander Agustin Alvarez Mayorga (defendant) identified by Florida Identification Card #A628097061000. While speaking with the defendant, I noticed a strong odor of an unknown alcoholic beverage emanating from the vehicle as he spoke. I also observed that the zipper on the defendant's shorts was open. The defendant's eyes were glassy, watery, and bloodshot. His gaze was also fixed. The defendant's speech was slurred. The defendant is Spanish speaking, but he stated that he had been drinking at his friend's apartment. The defendant stated that he had at least three beers.

I asked the defendant to exit the vehicle. As the defendant stepped out of the vehicle, I again observed that the zipper of his shorts was open. The defendant was asked if he would be willing to perform field sobriety exercises to which he agreed. A Spanish speaking officer assisted with the Field Sobriety Exercises.

The defendant was asked if he had any medical issues that would prevent him from completing the exercises. The defendant stated he did not. The defendant was read the instructions for each exercise and the exercises were demonstrated for the defendant in Spanish. The defendant stated he understood the instructions.

During Horizontal Gaze Nystagmus, the defendant had showed lack of smooth pursuit in both the right and left eyes, maximum deviation in both the right and left eyes, and nystagmus onset prior to 45 degrees in both the right and left eyes. Six decision clues noted. The defendant also swayed while balancing.

During the Walk and Turn, the defendant could not maintain balance while listening to the instructions, started before instructions were finished, stopped walking to regain balance, lost balance while walking causing him to step off of the line, used his arms/hands for balance, turned incorrectly as instructed, and took incorrect number of steps 12 steps up the line and 12 steps down the line. Six decision clues were noted.

During the One Leg Stand, the defendant swayed while balancing, used his arms for balance, hopped, and put his foot down. Four decision clues were noted.

The defendant was placed under arrest for DUI.

The defendant agreed to submit to a chemical test of his breath. The defendant was transported to the West Melbourne Police Department where a breath test was administered. The results of the breath test were 0.143g/210L and 0.140g/210L.

The defendant also acknowledged that he was not supposed to be driving since he did not have a valid Driver License.

The defendant was transported to the Brevard County Jail without incident.
