

On 01/30/2016 while patrolling the area of Peachtree Street and Prospect Avenue in my marked patrol vehicle I observed several individuals loitering in front of the business (904 Peachtree Street).

While still patrolling the area I observed a black male wearing a gray in color hooded sweater loitering in the business parking lot. I then kept patrolling the area as the black male kept walking back and forth. I then drove the area again and the male attempted elude me by walking in the opposite direction. As I kept patrolling the area the black male kept pacing the parking lot back and forth and made no attempts to go in the store. I then made contact with the black male who was later identified as Brandon Brown.

While speaking with Brandon Brown he stated that he did not have a Florida ID on his person and was very nervous. When asked what he was doing pacing in the area he stated "I was hanging with some friends". Brandon Brown was asked if he had anything illegal on his person like guns, drugs. Brandon Brown then began to act more nervous and kept touching his pockets, he was told not to reach into his pockets for Officer Safety. Brandon Brown had not been patted down, as I was just attempting to find out why he was in the area. When asked again if he had anything illegal on his person Brandon Brown reached for his pockets once again he was instructed by Officers to keep his hands up. At which point he went to reach for his pockets again I then told Brandon Brown to put his hands up and turn around to be patted down for weapons. I then asked Brandon Brown what was in his pocket and he stated that he had nothing but money. I then asked him if he wouldn't mind taking the contents out of his pocket and he then began to empty his pockets. While emptying his pockets on his jacket Brandon Brown attempted to conceal a clear plastic baggie in his hands, when asked he said "I have nothing". Brandon Brown had the clear plastic baggie clinched on his left first. I was then able to obtain the clear plastic baggie with a white like rock substance that was field tested on scene for cocaine. The white rock like substance tested positive for cocaine.

Brandon Brown was then read Miranda Warning on scene and stated that it was crack cocaine and it was for personal use. Brandon Brown made this statement while being recorded by my TASER body cam. A copy of the video was dropped into Evidence.Com. Also the cocaine was dropped into the Cocoa Police Department Evidence room. Brandon Brown Was then transported to the Cocoa Police Department for Booking and later turned over to the Brevard County Jail.
