On the above date and time, I observed a white SUV traveling West bound on SR528 that was unable to maintain a lane, traveling 15mph under the posted speed limit (45mph in a posted 60mph).

I initiated a traffic stop shortly after observing the driving pattern by turning on my red and blue emergency lights. After the vehicle came to a stop, I made contact with the arrestee, who was the driver of the vehicle. The arrestee exhibited bloodshot and glossy eyes at the time of my contact with him. At some point I ordered the arrestee out of the vehicle and began to speak with him in front of my patrol vehicle on the side of the road. I was then able to detect a strong odor of an alcoholic beverage emitting from his breath.

Based on the clues of impairment exhibited by the arrestee, the arrestee's driving pattern, my roadside contact with him, and my training and experience, I determined the arrestee was driving under the influence and unable to operate a vehicle safely.

At that time I requested the arrestee perform SFST's to which the arrestee agreed to and was willing to participate in.

During the horizontal gaze nystagmus exercise, The arrestee moved his head to follow the stimulus. The arrestee exhibited lack of smooth pursuit, distinct and sustained nystagmus at maximum deviation, and onset of nystagmus prior to 45 degrees in both eyes. The arrestee also exhibited vertical nystagmus in both eyes (6 Clues)

I explained and demonstrated the walk and turn exercise to the arrestee and they advised they understood. Upon being instructed to begin, the arrestee missed multiple heel to toe steps. While turning the arrestee made an improper turn and While walking back up the line the arrestee missed multiple heel to toe steps, and used his arms

for balance. The arrestee also took the improper amount of steps (approximately 4 clues).

Based on the clues of impairment exhibited by the arrestee, and the arrestee's driving pattern, my roadside contact with him, and my training and experience, I determined the arrestee was driving under the influence and unable to operate a vehicle safely.

I placed The arrestee under arrest for driving under the influence and requested he submit to an approved test of their breath for the purposes of determining the alcoholic content of his. The arrestee refused this test and I read him the legal duty and penalty for refusing the requested chemical test. The arrestee advised they understood the legal duty and penalty of their refusal and again refused to submit to a lawful test of their breath. The arrestee also refused said breath test knowing his driver's license would be suspended for a period of at least six months. \

After being placed under arrest but before being placed into the vehicle, the arrestee began to stiffen his body and attempt to move himself away from the patrol vehicle. At that time he was taken down to the ground and eventually placed into the back of the patrol vehicle.

It was determined that the vehicle the arrestee was operating has not been registered in the last 3 years and was unable to provide any registration for the vehicle.
