

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:
01/05/2025 00:30
On _____, at _____ (Specifically include facts constituting cause for arrest.)

On the above date and time, the above defendant, Isiah Johathan Green Gilbert, did commit the offense of fleeing to elude a law enforcement officer with lights and sirens activated.

As I was traveling northbound on Murrell Road from the intersection of Barnes Boulevard, I observed a black Lincoln four door sedan bearing Florida tag RSXT09 traveling northbound at a high rate of speed. As I continued northbound behind the vehicle from the intersection of Murrell Road and Gus Hipp Boulevard, I observed the suspect vehicle was gaining speed. I accelerated in an attempt to catch up with the vehicle and saw my speedometer was now at 60 mph while the suspect vehicle was still gaining distance from me and I estimated they were now traveling in excess of 70 mph. The posted speed limit on Murrell Road is 40 mph.

I radioed to other units to see if there was a unit on north Murrell Road. Corporal Turberville radioed back to me advising that she was at 7-11 (1901 Murrell Road). I advised her of the vehicle and description and that it was now traveling in excess of 60 mph and was passing Levitt Parkway. Corporal Turberville and Officer Fay were able to locate the vehicle and initiated their lights and sirens in an attempt to conduct a traffic stop however the vehicle continued northbound on Murrell Road and proceeded to go towards the intersection of Barton Boulevard.

Due to the vehicle approaching a populated area, I advised units to disengage from pursuing the suspect vehicle. Corporal Turberville advised the vehicle was last seen headed eastbound on Barton Boulevard towards US1. I advised Rockledge Dispatch to notify Cocoa PD and Brevard County Sheriff's Office of the vehicle and description, and that it fled from officers.

While waiting at the red light of Barton Boulevard and Murrell Road, I observed the suspect vehicle driving through the parking lot of Rockledge Flats located at 240 Barton Boulevard. I began following the vehicle as I believed the driver may exit and leave the vehicle in the parking lot. I later observed the suspect vehicle go around to the west side of Rockledge Flats and proceed to go westbound on Barton Boulevard.

I advised units via radio that the suspect vehicle was now westbound on Barton Boulevard headed towards Fiske Boulevard. As we approached the intersection the vehicle proceeded to go southbound on Fiske Boulevard. I initiated my lights and sirens to signal to the suspect driver that I was initiating a traffic stop. The suspect vehicle increased speed and continued southbound on Fiske Boulevard. As we passed the intersection of Fiske Boulevard and Eyster Boulevard I observed my speedometer of my vehicle was now at 80 mph. The suspect vehicle continued south on Fiske Boulevard and eventually came to stop at the entrance to the Milan subdivision (intersection of Case De Casa Circle and Fiske Boulevard). The suspect driver, identified as the above defendant was ordered out of the vehicle and taken into custody without incident. There were no other occupants inside the vehicle. I read the defendant his Miranda Warning at which point he declined to speak to officers.

The defendant was in operation of 2013 Lincoln 4 door sedan bearing Florida tag RSXT03 and operating it within the City of Rockledge, Brevard County, Florida. The defendant did willfully fail to stop when signaled through the use of emergency lights and sirens by law enforcement officers in marked patrol vehicles with agency insignia. My patrol vehicle has Rockledge Police jurisdictional markings prominently displayed on the outside and my emergency lights and sirens were activated at the time the defendant failed to stop.

The defendant was issued a criminal traffic citation for Flee to Elude LEO with Emergency Lights and Sirens Activated (AXPWXXE). An additional traffic citation was issued to the defendant for unlawful speed, 80 in posted 45 mph zone (AKPWXYE).

Pursuant to Florida State Statute 938.27, the investigative cost incurred by this agency is \$343.68.
